Bring documents Your version of the facts might be enough, but you can also bring documents to support what you tell them, such as medical reports or pictures. You are the actual victim of the theft, loss, or criminal mischief not a witness, relative, friend, etc. As noted below, you must directly contact Dayton PD for this. Examples: Detached garage door kicked in and tools, bikes, etc. Please make sure to turn off your pop-up blocking software before filing the report. If no complaint is made, the offence will not be prosecuted. You can report a crime at any police station or to the cantonal prosecution service, either verbally or in writing. Be notified of any problems with your report once it has been viewed by Police Personnel. You must file the complaint within three months of the incident. Procedure for a criminal case Since the same procedure has been followed in criminal cases in every canton: The police investigate what has happened. Ex-officio means the authorities will pursue the case irrespective of the wishes of the victim. It may be helpful to keep a record in a notebook of what you have done including all phone calls and anything that seems out of the ordinary or suspicious, to assist the police and help keep track of what still needs to be done. The accused can provide evidence that he or she is not guilty at any time. If the case has already been sent to the prosecutor, the prosecutor decides whether to continue with it. Withdrawing your complaint Even if you want to withdraw your complaint, the police can decide to continue the investigation. The public prosecutor is responsible for bringing the case to court and conducting the trial. Lost property is not a theft. You don't have to have a lawyer. It is not essential for you to have been personally affected by the crime. Before continuing, you should be aware that it is a crime to make a false police report. Criminal complaints â€” useful information If you do not have the legal capacity to file a report, your legal representative can do it for you. Carers, family members and friends can complete in advance, a form recording all vital details, such as medication required, mobile numbers, places previously located, a photograph etc. Reporting a crime â€” useful information: Anyone who is aware that a crime has been committed can report it. However there are a number of things that can try to do and find them before contacting the police. This process can take several days, weeks or months.
